From the Archives - Romance around the Restaurant By Suzy Crawford

The archives of San Dimas do not always tie up all the loose ends. Photographs are almost always our starting point but then you have to dig in. With the aid of genealogical research tools (Ancestry.com, Family Search, Find-a-Grave, Census files) you can find personal notes, records, family trees and more that can give you connections or, at least some Real Good Hints to use some of the software tools jargon.

Researching a few Bills of Sale, Anita Drexel of Santa Monica and Mary L. Reynolds of San Dimas sold an eating establishment, the Mary Jane Cafe, to Muriel F. Mayhew in 1936. The Bill of Sale itself is entertaining as the inventory was itemized down to the number of forks, spoons and plates.

The Mary Jane Cafe was located at 128 West Bonita Avenue. It has since been torn down, along with additional buildings along that section of Bonita and new structures have been built. But thanks to the archives, the story remains.

The San Dimas Garage (Early Ford Store) was located at 108 W. Bonita Avenue, just a few steps east on the street from the Mary Jane Cafe. Now in the 1930's, I would expect that many citizens would walk from the surrounding neighborhoods to Bonita Avenue for work and shopping.

Guess who worked as a mechanic at the garage? One Mr. Lloyd Wilbur Moore. And being the restaurant was just a few steps down from the garage, how many lunch breaks were enjoyed at the Mary Jane Cafe? Hmmm? Who caught Lloyd's fancy or was it the other way around? Or was it only as Muriel walked to work, past the garage to the Mary Jane? Some loose ends never get tied up, but you can complete the story anyway you would like.

But the old adage of 'Hard work pays off' can apply in a variety of ways and you get to choose where it fits in this story:


- Muriel F. Mayhew married Lloyd Wilbur Moore on August 28, 1937.
- Muriel sold the Mary Jane Cafe in 1940 for a whopping \$750, profiting \$350 over the course of four years.
- Lloyd, Muriel and their sons continued to live at 126 East Second Street for many years.
- Muriel's son, Richard Mayhew worked at San Dimas Ace Hardware in the 1970's with historical society member Dave Harbin. Dave remembers delivering items to Mrs. Moore on his way home from work.




Taken from a letter from Gracie
